Justification:

 Increase in physical target of 25.76 sq.m. (from 381.60 sq.m. to 407.36 sq.m.) due to the needed increase in the bridge length based on design analysis.

- Change in specific type of work from Widening (Construction of Parallel Bridge) to Widening (from 2-4 lanes), i.e., additional of lane both sides, due to Right-of-Way (ROW) issues, affecting structures like Solar Dryer, residences, and posts of electric and Globe telecommunications. There is also, an issue on Geometric Alignment of the transition road (approaches) of parallel bridge to existing Four (4) lanes carriageway of the adjacent roadway, which is part of Daang Maharlika (Surigao-Agusan Section). The said transition road of the upgraded parallel bridge will overlay the newly finished road widening implemented by the Regional Office funded under FY2018 GAA.
- The decrease in unit cost is based on approved POW and DUPA.

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
