- The Physical Target of this project has reduced from 9.104 lane km. to 4.886 lane km. because of the tremendous excavation works needed to attain the required gradient in conformity with the DPWH design specifications including the provision of slope protection structures and drainage facilities which eventually resulted to a sharp increase in the unit cost from P12.719M/lane km. to P23.700M/lane km.
- 2. The official title of this project was actually formulated based on what has been indicated in NEP, NEP with Errata and HGAB which did not include the term "Package 1", hence, the said term is no longer included in the modified version. It must be noted that the preparation of plans, POW and ABC were undertaken during the NEP stage wherein the project title adopted in the aforementioned documents also did not indicated the term "Package 1".

Based on our evaluation, the submitted request for modification of the said project is in order. Hence, the said request is hereby recommended for Secretary's consideration and approval.
