1. The original amount of the Right-of-Way (ROW) component originally indicated in MYPS for this project will have to be increased in view of a higher unit cost as determined based on the fair market value of properties within the locality concerned that will be affected by the road widening works. In this instance, the ROW physical target of 39,215 sq.m. will still have to be pursued to clear the area needed to fully implement the civil works.

Given the significant increase in the cost of the ROW component which is herein proposed to be pursued by virtue of 2. the reason cited in Item 1 above, the cost of civil works consequently will have to be reduced correspondingly which thereby also decreases the Physical Target.

Based on our evaluation, the submitted request for modification of the said project is in order. Hence, the said request is hereby recommended for Secretary's consideration and approval.
