lustification:

- Adjustment of the station limits to include the critical sections which will avoid further accident to the riding public in times of extreme weather condition;
- The average height for the slope protection structure is 5 meters thereby mitigating the use of stone masonry / crib wall instead of a grouted riprap;
 The decrease of the unit and in the solution of the unit and in the solution.
- The decrease of the unit cost is in accordance to the prevailing cost prescribed under the guidelines of DUPA and the limits set forth by the Department.
