area as per records of Barangay Poblacion, Muntinlupa City, thus, considering only the Rizal Street. Decrease in physical target of CW1 from 500 l.m. to 380 l.m. was due to the road thickness (0.25m) and the drainage, which uses additional RCPC (0.610mm dia.) to suit actual field condition. The choice of design was in consideration that Rizal Street is a busy road in view of its location.

• The unit cost increased due to the decrease in physical target without changes in the allocation.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
