Justification: The original physical target of 1.656 Lm is reduced to 896 Lm due to the change in design of structure to be constructed at 6-layers instead of 4-layers gabion type slope protection works. The change in design is necessary to attain more stable structure to serve the purpose. This decrease in the physical target resulted to an increase in the unit cost from P27.82T/Lm to P51.42T/lm based from the approved Plans, Detailed Unit Price Analysis (DUPA) and Program of Works (POW).

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
