JUSTIFICATION:

The modification was requested due to the changes in station limits and decrease in its physical target by 0.70 lane km (from 3.212 lane km to 2.512 lane km). The reduction was caused by the inclusion in the scopes of work, the construction of line canal and paving of shoulders equivalent to 2,512 sq.m. in order to mitigate inland flooding in the affected area. Also, considerable amount was allocated for the Right-of-Way acquisition which was not provided in the FY 2017 GAA, thus, the request for modification is necessary.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), Program of Work (POW), Detailed Unit Price Analysis (DUPA), Straight Line Diagram, Location Map, Geotagged Photos, BP202 and Certificate of Availability of Funds (CAF).

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
