Justification:

- Based on the Approved POW and DUPA the physical target decreases from 1.930 lane km to 0.804 lane km.
- The scope of work includes Item 200(1) Aggregates Subbase Course of 0.30 meters thick which constitutes 38.63% (₱ 3,824,591.91) and Surface Courses of 52.47% (₱ 5,194,601.00) of the total project cost.
- Inclusion of miscellaneous structures such as Reflectorized Thermoplastic Pavement Markings for centerline and edge line which is 0.84% of the project cost contributed to the increase in cost per kilometer of the road project.
- Also, this project is located in an Island where materials cost is extremely high due to double/triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source in the Province of Sulu is limited.
