Justification:

- Provision of physical target to determine the actual length based on the Approved POW and DUPA.
- The scope of work includes Item 200(1) Aggregates Subbase Course of 0.30 meters thick which constitutes 35.69% (₱ 3,532,986.65) and Surface Courses of 55.40% (₱ 5,484,118.36) of the total project cost.
- Also, this project is located in an Island where materials cost is extremely high due to double/triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source in the Province of Sulu is limited.
- The derived unit cost is based on approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
