## **Justification:**

- Provision of physical target to determine the actual length based on the Approved POW and DUPA.
- The scope of work includes Item 200(1) Aggregates Subbase Course of 0.30 meters thick which constitutes 37.74% (₱ 3,736,206.55) and Surface Courses of 56.18% (₱ 5,561,679.55) of the total project cost.
- Also, this project is located in an Island where materials cost is extremely high due to double/triple handling cost. Aggregate subbase and surface courses are being taken from Cotabato City since the source in the Province of Sulu is limited. The derived unit cost is based on approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).



Based on our evaluation, the submitted request for project modification is in order, hence approval hereof is recommended.
