### Justification:

- Quantification/Provision of Physical Target to determine the actual length based the result of the preliminary detailed engineering activities.
- The road design includes miscellaneous structures such as 40,900 square meters of Item 612(1) reflectorized thermoplastic pavements markings (white) and 5,000 square meters of Item 612(2) reflectorized thermoplastic pavements markings (Yellow) which constitutes 98.29% (₱ 43,652,975.59) of the total project cost.
- The project covers the painting/repainting of centreline and edge line of 8 National Roads under Zamboanga del Norte 1st Legislative District namely: (1) Dipolog-Orquieta Rd; (2) Dipolog-Punta-Dansullan Sergio Osmena Road; (3) Rizal-Dakak-Dapitan Coastal Loop Road; (4) Dipolog-Polanco-Pinan Jct Oroq Road; (5) Pinan-Mutia Rd; (6) Jct. Polo-Dapitan Park Road; (7) Dipolog-Polanco-Macleodes Rd.; (8) Jct. Polo-Pulauan Port Road.
- The derived unit cost is based on approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
