	 Justification: Original work (construction of concrete road) was replaced with construction of gravel road (including change/increase in physical target) and with substantial cost due to: The road is narrow (up to 3m only), hence, construction of gravel road/improvement of road was prioritized to make the road passable and for road safety purposes; There is a need to open/widen/downgrade the road (especially along rolling terrain) to conform with the DPWH Design Guidelines and Standards (Horizontal and Vertical Alignment and Road Width). As such, the need for substantial amount for said improvement/gravelling; and Said major changes in the vertical and horizontal alignments require voluminous excavation. Road design 					

Said major changes in the vertical and horizontal alignments require voluminous excavation. Road design
requires (6m carriageway width) side cuts of involving 96,527 cu.m. of excavation materials. With said
earthworks requirement which require substantial cost, the allocation for the road could not cover the
concreting of the road.

Based on our evaluation, the submitted request for modification is in order, hence, it is respectfully recommended to the Secretary for his consideration and approval.
