## **Justification:**

Decrease in physical target from 3.339 lane km to 1.934 lane km due to the following:

- There is considerable cost for asphalt overlay (80 mm thick) due to the inclusion of "Anti-Rutting Additive" (ARA) to prevent the road surface from rutting since this section is located in a highly urbanized area especially that heavy and 10-wheeler trucks and cargo are traversing this road. ARA is recommended to be used in asphalt overlay projects that will carry more than 2000 vehicles per day to improve the quality of asphalt per DO 11, s. of 2019;
- Asphalt overlay for two (2) lanes was considered for the project instead of four (4) lanes since
  - drainage improvement on the outer lanes is still on-going, funded under FY 2020 GAA;
- Two junctions with a length of 30 meters and 110 meters having 13.4 meters width along the road section were also considered for asphalt overlay for road safety purposes; and
- Scope of works also includes raising of 8 manholes' elevation to avoid uneven grade line and other miscellaneous structures such as installation of internally illuminated (solar) pavement levelled marker/stud flush type omnidirectional and application of reflectorized thermoplastic pavement markings.
