The physical target based on General Appropriations Act 2023 is 580 lineal meter, it should be 362 lineal meter as per Approved Plan and Program Works.

The unit costs have increase based on the approved DED in consideration of the approved 4th Quarter of 2022 Construction Materials Price Data (CMPD). Said estimates were considered reasonable per approved POW/DUPA.
