Justification:

The modification is hereby sought due to the following reasons;

- Change in station limits. The station limits were moved backwards to cover the portion of the road section which are in poor condition. Since K0068+175 - K0068+300 is already part of San Agustin (Bomba) Bridge, limits were restricted to K0068+175.
- Inclusion of K0069+102 K0069+230 to have continuity with P00603786LZ (GA FY 2022). Although it
 is in condition based on rocond data, this part of the road section always gets flooded during rainy
 season that is u was prioritized for rehabilitation.
- The released allocation is sufficient to cover the increase in physical target with reference to Programs
 of (POW) and Detailed Unit Price Analysis (DUPA) for which prevailing prices of materials were used.
