- Change in station limits. The modified stations still need immediate rehabilitation though they are in good and fair conditions as per Rocond data. This road section is the only part of S01233LZ that is not elevated which is the reason why the area always remains flooded during rainy seasons.
- Increased in unit cost and decrease in physical target is a consequence of raising of grade of the proposed project. Also, there is a provision of box culvert at K0072 + 085.25 - K0072 + 089.60 which also affects the rise in unit cost.
