- Change in Barangay and Town since Sitio Zaputi does not exist in brgy. Hacienda Dolores, Porac. Hence, it is situated in Brgy. San Pablo 2nd, Lubao. Further, the proposed project is actually in Sitio Zaputi wherein as per detailed engineering, continuity of the existing concrete pavement is necessary to decrease travel time in the delivery of goods and services from and to the area.
