<ul style="list-style-type: none"> Increased in physical target in accordance with the derived unit cost based on approved POW and DED consolidated on the latest CMPD. The proposed reconstruction of the pavement was designed with reinforced 350mm thick slab. Since the MNR under the 5th LD of Bulacan will serve as an alternate route in support to the on-going rehabilitation of Candaba Viaduct. Therefore, it is necessary to provide reinforcement to the design due to the overloaded vehicles that were anticipated to pass through. Will serve as continuity of the FY 2023 projects (i.e., P00712943LZ and P00712995LZ). Prioritized the sections which were identified with severely damaged pavement. Also, shoulder improvement with thickness of 280mm is included in the scope of the project.


