Modified station limits. Prioritized the road section with current fair to poor condition in order to
prevent the existing concrete pavement from further defects and prolong its life span.

- Moreover, the decrease in the overall length and physical target of the project was due to the derived unit cost based on the approved POW and DED.
- The unit cost increases since we adopt the costing of major items (i.e., Item 302(2) and Item 310(12)c) from the latest issuance of canvas of materials submitted by the accredited suppliers of this Department. Also, the pavement was designed with 100mm thickness with the provision of miscellaneous structures such as Reflectorized Thermoplastic Pavement Markings.
