Justification:

- Change in Type of Work to Construction of Gravel Road. The allocation for this project will serve as the continuation of the two projects under GAA 2023 (i.e., P00739768LZ and P00739768LZ) and will cover the road opening of the missing link which will connect to an existing new concrete road. Due to insufficient budget for this project, concreting of the priority section is not workable since
- 98.75% of the budget for civil works was allocated for the road opening which will cover the computed huge volume of items for excavation works (i.e., Surplus Common Excavation, Surplus Rock Excavation (Soft) and Surplus Rock Excavation (Rock)). The alignment of the project is located on the mountainous area of Mariveles, Bataan.
