Justification:

- The Decrease of physical target from 7.652 Lane Km. to 3.832 Lane Km. was due to the following:
 - Based on PDE as per approved Program of Works and the updated Detailed Unit Price Analysis. Also, the direct and indirect effects of Oil price increase such as Equipment used in construction affected the change in physical target since their rates depends heavily on Oil products which is volatile in the recent set-up.
 - The station limits were changed to prioritize roads which are in fair condition under ROCOND 2022.
 - The additional scope of works, including primarily reblocking works at segments where these are deemed necessary.
