Justification:

- The decrease in Physical target from 811 Lineal Meters to 543 Lineal Meters was due to the additional works caused by the relocation/transfer of existing Street Lights to make way for the construction of this project.
- Based on PDE as per approved Program of Works and the updated Detailed Unit Price Analysis. Also, the direct and indirect effects of Oil price increase such as Equipment used in construction affected the change in physical target since their rates depends heavily on Oil products which is volatile in the recent set-up.
