Justification:

 The current state of the additional segment on the station limits is in poor condition. Thus, adjustment to the station limits is essential for the segment that needs immediate attention.

- The target is based on the actual PDE and the current actual market prices. The project includes a 80mm thickness of asphalt overlay with the reblocking of damaged paved roads (see attached approved POW and Plan).
- Likewise, 7.40 percent (7.40%) of the appropriations was intended for miscellaneous structure (road safety features) (i.e., Reflectorized Thermoplastic Pavement Markings, Solar LED street lights, Solar Studs, Regulatory Signs and Warning Signs)
