- Unit price of item 302(2) Emulsified Asphalt and item 310(1)c Bituminous Concrete Surface Wearing Course, Hot laid (50mm thk) increased. The derived unit cost was based on the approved DUPA and POW with reference to the corresponding Construction Materials Price Data/Canvass.
- Correction in station limits. During the ocular inspection and conduct of Preliminary Detailed Engineering, the station limits was changed to prioritize the road segments with defects wherein immediate construction is required.
