Justification:

- Unit price of item 302(2) Emulsified Asphalt and item 310(1)c Bituminous Concrete Surface Wearing Course, Hot laid (50mm thk) increased. Thus, physical target is decreased. The derived unit cost was based on the approved DUPA and POW with reference to the corresponding Construction Materials Price Data/Canvass.
- Correction in station limits. During the ocular inspection and conduct of Preliminary Detailed Engineering, the station limits was changed because it overlapped with another project.
