Justifications:

 Modification of project limit has increased in length for the allocated fund for the project is more than enough for the stations determined in the GAA. Thus, addition of project length is necessary to utilize the entire fund allocated resulting to an increased in length from 2.124 lane km to 2.316 lane km. The unit cost is based on the uniform width (2-lanes) of the station limits.
