- 1. Adjustment in component cost and physical target of CW1 from 2.656 lane km to 1.272 lane km to prioritize the remaining unwidened road sections.
- Change in scope of work of CW2 from "Construction of Concrete Bridge" to "Construction of Concrete Road" to prioritize the paving of the remaining gap sections along the road alignment.
