- Modification is brought about by the change in the end limits of the project from K0339+187 it will become K0339+832 and an additional limit (K0340+000 - K0340+200),
- The physical target of 1.961 lane km, (as reflected in the GAA) does not coincide with the project station limit as proposed. The correct physical target should have been 0.486 lane km.
- The CW2 of the project was deemed necessary for it has a POOR condition based on the recently conducted ROCOND survey on that road section.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
