- Modification is brought about by the change in the station limit from (K0352+426-K0354+000) to (K0346+040- K0346+240, K0346+240 - K0348+182) because the new station warrants Rehabilitation/ Reconstruction.
- The original station limits is still considered to be in FAIR condition based from the assessment during the conduct of ROCOND.
- The CW2 of the project was deemed necessary for it has a POOR condition based on the recently conducted ROCOND survey on that road section.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
