 Based from the latest result from road condition data, Buenavista – Kawayan Rd - K0058+449 - K0059+400 has already been widened and upgraded the inner lane.

• Decreased in physical target due to the increase of some material prices based in the latest canvass and CMPD in the 4th quarter of 2021, and insufficient amount to cover the entire length.
