Justification:

Modification is sought due to:

1. Change in station limits to prioritize the widening of gap sections along the road which resulted to the decrease in physical target of CW1 from 2.944 lane km to 1.978 lane km.

2. The increase unit cost per square meter of CW1 is also due to revised costs of construction materials based on updated canvassed prices in pursuant to Department Order No. 63, Series of 2022, Guidelines in Addressing the Effect of the Increasing Prices of Construction Materials and Equipment Rental Rates Utilized for Infrastructure Projects.

3. ROW Component is identified for payment of affected structures/lots and properties.
