<ol style="list-style-type: none"> Change in station limits to prioritize flood prone road sections which resulted to the decrease in physical target of CW1 from 1,571.9 lineal meters to 875.00 lineal meters. The increase in unit cost per lineal meter of CW1 is due to the inclusion of sidewalk and streetlighting for road safety. <i>→ could be based on DPWH design standards</i> Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, GIS Map, Certificate of Reasonableness of Cost dated January 30, 2023.
