Justification:

Modification is sought due to:

- Adjustment in the station limits due to increase in unit cost per lane km of CW1 based on updated canvassed prices in pursuant to Department Order No. 63, Series of 2022, Guidelines in Addressing the Effect of the Increasing Prices of Construction Materials and Equipment Rental Rates Utilized for Infrastructure Projects which resulted to the decrease in the physical target from 7.007 lane km to 3.571 lane km.
- 2. Inclusion of CW2 Construction of Drainage Structure along Road (Line Canal with Concrete Cover) to address flooding in the area and prevent damage on the road section.
- Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, GIS Map, and Certification on the Reasonableness of Cost dated March 28, 2023.
