Justification:

Modification is sought due to:

1. Change in station limits to prioritize the asphalt overlay of outer lanes in fair – poor condition based on the rocond result as of October 14, 2022 for homogenous pavement surface and road safety along this section.

2. Adjustment in the station limits due to the increase in unit cost per lane km of CW1 based on updated canvassed prices in pursuant to Department Order No. 63, Series of 2022, Guidelines in Addressing the Effect of the Increasing Prices of Construction Materials and Equipment Rental Rates Utilized for Infrastructure Projects which resulted to the decrease in the physical target from 5.769 lane km to 5.622 lane km.

 Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, GIS Map, Official Result of Road Condition as of October 14, 2022 and Certification on the Reasonableness of Cost dated January 30, 2023.

Based on our evaluation, the submitted request for modification of the said project is found in order. Hence, the said request is hereby recommended for the Secretary's consideration and approval.
