**Justifications:**

1. Change in station limits to prioritize the critical road section that needs construction of slope protection structure in order to stabilize the slope and to prevent pavement failure for the safety of the travelling public.
2. Said changes resulted to the decrease in physical target from 2,400.380 Square meters to 2,392.14 Square meters and consequently increase in unit cost in view of the design used for slope protection structure (concrete slope protection with steel sheet pile, stone masonry) and other essential items of work necessary in the project, as well as the effect of the increasing prices of construction materials, equipment rental rates and updated labor rates, copy attached is Certificate of Reasonableness of Cost Estimate for your reference and guidance.
3. Attached are the following supporting documents: Form for Evaluation of Modification Request (2023, V1.0); BP 202; Certificate of Availability of Funds; Approved Program of Works; Plan; Geotagged Photos; Certificate of Reasonableness of Cost Estimate; and Location Map.
