Justification: Modification is sought due to:					

- Change in station limits to prioritize landslide prone road sections which resulted to a
 decrease in physical target from 296.14 sq.m to 221 sq.m based from the actual area
 covered by the project.
- The increase in unit cost per sq.m. is due to the voluminous quantities of earthworks (structure excavation and embankment) and the provision of metal guardrails for road safety.
- Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds and Certification on the Reasonableness of Cost dated February 2, 2023.
