## **Justification:**

The modification is sought due to:

- 1. Change in station limits to prioritize the reconstruction of dilapidated road sections with bad condition which resulted to the decrease in physical target from 2 lane km to 0.528 lane km.
- The increase in unit cost per lane km of CW1 is due to voluminous quantities for earthworks (removal of structures and obstruction, unsuitable excavation, structure excavation, subgrade preparation), provision of drainage structure (concrete lined canal) and precast concrete curb and gutter.
- 3. Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, Geotagged Photos, GIS Map, and Certification for Reasonableness of Cost dated February 07, 2023.

Based on our evaluation, the submitted request for modification of the said project is in order. Hence, the said request is hereby recommended for Secretary's consideration and approval.
