Justification:

- Increase in unit cost/decrease in physical target by 10.20 Lane Km (from 31.400 Lane Km to 21.200 Lane Km) due to the additional concrete reblocking activity that comprises 14.912% of the construction
- Change of station limits to;
 - Recompense with the change in the physical target.
 - ${\scriptstyle \circ}$ Prioritize reblocking of slabs that require immediate corrective measures.
- The derived unit cost is based on the approved Program of Works (POW) and the Detailed Unit Price Analysis (DUPA) and shown on.
- Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), BP202, Geotagged photos, and GIS Map.
