## Justification:

- Change in the project location to avoid overlap with the on-going construction of slope protection structure funded under GAA FY 2021.
- Decreased in unit cost/increased in physical target due to the actual site condition of the new station limits that require lesser volume of earthworks.
- Derived unit cost is based on the approved Program of Works (POW) and Detailed Unit Price Analysis (DUPA).
