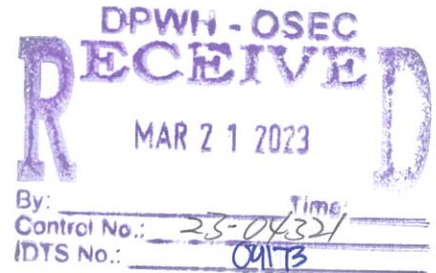

Justification:

- **Typographical error.** The project description Apayao-Cagayan (Ili-Guinamgamman-Rizal Road) should be Cagayan-Apayao Road (Ili-Guinamgamman-Rizal Sect) since this is the registered name of the road line in the RBIA.
- Change in station limits of the project from Chainage 0 – Chainage 3027 to Chainage 4548 – Chainage 6448 in order to provide immediate ease of access road to the populated inhabitants in the area boosting the economic activity and delivery of construction materials to the project site particularly during the rainy season. This will also avoid the longer route which consumes longer travel time.
- The modified road will improve the lives and increase the standard of living of the residents.
- The decrease in the physical target/increase in the unit cost is due to the **provision of roadside structures (slope and embankment protection, breast walls)** for the stability of the road and safety of the road users.
- Attached are the following documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, Road Condition, BP 202, Geotagged photographs, Certificate of No Overlapping, ROW Clearances, Social Clearance, Environmental Clearances, **Certificate of Reasonableness** and Materials Source Map.

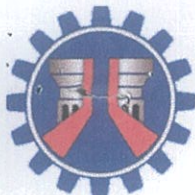


