Justification:					

The increase in unit cost/decrease in physical target CW1- Road Widening from 2.216 lane km to 1.654 lane km is due to:

- The inclusion of reinforced concrete retaining wall from K0333+872 -K0333+932 with varying height ranging from 2.5m to 6.0m. The retaining walls will be made out of Reinforced Concrete, Grade 40 and Structural Concrete, 20.68 Mpa, Class "A", 28 days, and the cost is equivalent 14.70% of the total direct cost of the project.
- The provision of thermoplastic pavement markings, removal and transplanting of trees which is 1.30% of the total direct cost of the project.
- The Road Widening will be made out of Portland Cement Concrete Pavement (Unreinforced), 0.30m thick, 14 days and will cover 65.98% of the total direct cost of the project.
- The project includes the cost for relocation of affected electric utilities.
- The change in the project limit was made to coincide with the decrease in the physical target.

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW), and Detailed Engineering Design (DED) Plan.
