Justification:

Modification is sought due to:

- The decrease in unit cost/increase in physical target of CW1- Road Widening due to the minimal requirement of the Earthworks, Subbase and Base Course.
- The project includes curb and gutter, sidewalk and thermoplastic markings along the station limits, the cost is 17.94% of the total direct cost of the project.
- The change in station limits was made to cover the remaining unwidened side (R/S) outer lane and synchronize with the increase in the physical target.

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW), and Detailed Engineering Design (DED) Plan.
