Justification:

- Recommended new road section - the road is in need of immediate Construction of Drainage System (r/s) to prevent damage to properties and ensure safety of motorists with the frequent major flooding during heavy rains in the area
- An efficient Type III lined canal drainage system along the project site will allow water to flow freely and lessens or mitigates the likelihood that water will accumulate and cause the community to flood
- In addition, the programmed 351 l.m. type III lined canal will be built and connected to an already existing type III lined canal along site
- Inclusion of pavement construction of shoulder provided for emergency use by traffic
