- Decrease in physical target from 0.798 Lane Km to 0.54 Lane Km of the project, maximizing the budget based on the Detailed Estimate and Actual Survey Plans, while also prioritizing important road portions that need to be reconstructed
- Immediate need to reconstruct to concrete the existing deteriorating road condition with a "Fair" and "Poor" rating based on the latest FY 2022 RoCond Result that is beyond preventive // maintenance repair/rehabilitation
- Revalidation of the project site shows the deterioration of existing asphalt overlayed section as "Bad" //
- Upgrading of existing 230mm PCCP base to 300mm in accordance with the latest D.O. on the minimum pavement thickness of national roads
- Project for modification is further justified with the latest photos showing the Bad condition of the road section
- Inclusion of road safety features such as single arm post, with street light, 8m, VED, 130W in order to
 provide illumination within site to safeguard pedestrians and motorists.
