Justification:

Modification is sought due to:

- The decrease in unit cost/ increase in physical target of CW1 Construction of Road Slope Protection Structure is based on validated and approved Detailed Unit Price Analysis (DUPA) and Program of Works (POW).
- Increase in the physical target to maximize the utilization of the allotted funds and cover areas requiring slope
- The slope protection structure will be made out of stone masonry with a height of 4.10 meters, and the corresponding cost is equivalent to 87.54% of the total direct cost of the project.
