Change in Station Limits in the Project Description and Increase in physical target for CW1 - Construction of Road Slope Protection Structure from 1,837.55 Square Meters to 2,869 Square Meters due to the following:

- The change in station limits was deemed necessary to address the critical areas along the road section requiring immediate slope intervention.
- The decrease in unit cost for CW1 is due to the change of slope mitigation structure from active wire mesh system to the construction of double cribwall including widening.
- The derived unit cost is based on the approved Program of Work (POW) with Detailed Unit Price Analysis (DUPA).
