Justification: <i>Use of Rockfall Netting</i> <ul style="list-style-type: none">• Increase in physical target/decrease in unit cost for CW1 – Construction of Road Slope Protection Structure based on the validated/ approved Detailed Unit Price Analysis (DUPA) and Program of Work (POW).• The project is composed of Rubble Concrete, Erosion Control Mat (Type 4), Permanent Ground Anchors (for Active Wire Mesh), Hydroseeding and Wire Mesh (High Tensile), consisting 98.61% of the total direct cost.• The allotted fund is sufficient to cover the increase in the physical target.• Maximize the utilization of the allocated fund for the project.• The change in station limit is due to prioritization of road sections found in immediate need of slope protection, and also, to synchronize with the increase in the physical target.


