Justification:

- Increase in physical target for CW1 Road Widening from 6.25 lane km to 8.886 lane km are due to the following:
 - Decrease in estimated cost per kilometer of the road widening project due to the reduction of aggregate subbase course thickness from 0.30m to 0.20m. Some structures such as reinforced concrete retaining wall, concrete lined canals and other pay items previously included in the original proposal are deleted since it is not required throughout the entire length of the project.
 - Thus, the released allocation is more than enough to complete the proposed original length, hence to maximize the utilization of allotted budget, the physical target has been increased.
- Inclusion of RROW component for payment of affected structures due to widening to avoid delay in project implementation.
- The change in project title was made to state/include the actual limits in the project title to clearly delineate the start and end limits of the project.
- Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not within Warranty Period", Geotagged Photographs, Approved Program of Works (POW), and Approved Detailed Engineering Design (DED).
