Decrease in physical target of CW1 - Construction of Road Slope Protection Structure from 1,388.889 square meters to 1,320.000 Square meters is due to the following:

Updating of Item 522- 4a (Active Wire Mesh System) for its unit cost. The allocation is sufficient for the construction of road slope protection with 60 meters height of active protection system

and 22 meters length based on the submitted approved Certificate of Reasonableness of Cost Estimate reflecting a 95.73% Drainage and Slope Protection Structures of items of work.

The change in project title is due to:

Inclusion of the actual station limits in the project title to prevent overlapping with future projects.
