Decrease in physical target of CW1 – Construction of Road Slope Protection Structure from 5555.556 square meters to 3855.00 Square meters is due to the following:

Inclusion of Item 522-4a (Active Wire Mesh System) and Item 522(7)a (Catch Fence)
 The allocation is sufficient for the construction of road slope protection with 30 meters height of active protection system with 128.50 meters length and Catch Fence with 3 meters height perpendicular to the mountain slope and 128.50 meters length based on the submitted approved Certificate of Reasonableness of Cost Estimate reflecting a 97.77% Drainage and Slope Protection Structures of items of work.

The change in project title is due to:

Inclusion of the actual station limits in the project title to prevent overlapping with future projects.
